### THE LOCAL POSTCARD PAGE

#### PART 48 – DIANA FOUNTAIN – BUSHY PARK

The Diana Fountain is a bronze statue of a goddess on a marble and stone fountain surrounded by bronzes of four boys, water nymphs and four shells. It is located at the centre of a round pond at the junction of chestnut and lime avenues in Bushy Park.

Designed in 1637 at the request of King Charles I for his wife Henrietta Maria, it originally

stood at Somerset House. In 1656 the fountain was moved to Hampton Court on the orders of Oliver Cromwell and in 1713 moved to its current position in the middle of the Christopher Wren designed Chestnut Avenue in Bushy Park. The site now forms a large traffic island which is circular and contains a 400-foot (120 m) diameter pool surrounded by lawns, with the Diana statue on a tall base in the middle of the pool.



The female figure on top of the fountain has over her long life been known as Diana, Arethusa, Venus and even Prosperina , and recently some younger visitors take her for Diana, Princess of Wales. The official view is now firmly that she represents Arethusa, although the fountain continues to be known as the "Diana Fountain". In 2009 the fountain was restored as part of the Bushy Park Restoration Project and the main statue re-gilded. The fountain was listed as Grade II in 1952, and in February 2011 reclassified as Grade I.



Our picture is in fact a postcard sized Reward Card which dates from somewhere around 1895 – 1910 I would think. These were given out by school boards, in this case the London school board, to pupils with excellent attendance records or for exceptional work.

The Reward Card painting shows a much smaller pond and a quite basic pathway around it. Unfortunately the artist and date of the painting are unknown (unless you know better of course) so there may have been a bit of artistic licence on this one. Tarmac was yet to be invented as we moved into the 20th century and it is interesting to see that the card is captioned as Hampton

Court rather than Bushy Park. I suspect the painting is a bit older than the card itself.

# Twickers Foodie In a Pickle over Christmas

Christmas isn't Christmas without pickled walnuts. The very thought of turkey sandwiches on Christmas evening or cold turkey (if you'll pardon the pun) on Boxing Day without the accompaniment of pickled walnuts just doesn't bear thinking about for this particular foodie. So I always



make sure I have a new jar in the cupboard as part of my pre-Christmas preparations. The famous name for pickled walnuts, of course, is Kent-based Opies – in fact our only commercial producer of pickled walnuts and one of the oldest family-owned firms in the UK.

If you are new to pickled walnuts, their soft texture may be something of a surprise. According to Opies, the nuts are picked from the trees at their absolute prime, in late June/July while still green, before the shell has had time to form or the squirrels have managed to raid them! Then they are hand selected, cooked gently and then left to mature in a closely guarded secret spiced malt vinegar recipe. Since Victorian times they have been a staple on the British festive table – and quite rightly so in my opinion.

Pickled walnuts are great recipe ingredients too – they add that umami element to many dishes. If, like me, you still have a few left in your jar from last Christmas, (which will have softened a lot), don't chuck them away. Instead, use them in this lovely recipe for Creamy Gorgonzola and Pickled Walnut Pasta, which of course will be also be a great standby for a post-Christmas meal. And don't forget to buy a fresh jar in plenty of time for this year!

## Creamy Gorgonzola and Pickled Walnut Pasta

A quick and easy lunch, dinner or supper made in just half an hour and impressive enough for entertaining

Serves 2

Preparation time: 15 minutes Cooking time: 15 minutes Ingredients:

400g penne pasta

1 tbsp olive oil

1 red onion finely chopped

1 green pepper finely chopped

500ml whipped cream

250g gorgonzola, crumbled

200g Opies pickled walnuts in malt vinegar,

chopped

15g fresh basil, chopped

Salt

Black pepper

#### Method:

- 1. Cook the pasta according to pack instructions in a large pan of boiling water, drain, return.
- 2. In a separate pan, heat the olive oil add the onion and pepper and cook for approximately 5 minutes until soft.
- 3. Add the cream, gorgonzola and walnuts and stir until the cheese melts. Season to taste.
- 4. Stir the sauce into the pasta.
- 5. Transfer to a serving dish and sprinkle with chopped basil



## Kean-Eyed The Dramatic Exploits of Edmund Kean



Exchange Theatre, Twickenham, 5th November Review by Matthew Grierson

Can we love a fine performer who is a dreadful man? It's a question we should ask of the Romantic tragedian Edmund Kean. In Ian Hughes' absorbing one-man show, the first thing we learn about him is that he – Kean – is making his wife, who is six months pregnant, walk 180 miles to Swansea where he has been offered a job. Yet



he – Hughes – pursues the tragic arc of Kean's career from strolling player to West End star, then to sozzled has-been, with such virtuosity that it is difficult not to sympathise with him.

This is partly a function of Hughes' writing, which aims to showcase both his own and Kean's versatility, and he deftly manages the lightning mood changes required when, for example, his joy at being invited to perform at Drury Lane becomes bereavement and impotent rage at his son's premature death. But it's also partly that Kean has to be built up, because a performer from the age of the stage leaves no direct record for the present in the way that (say) his contemporary Lord Byron does. So Hughes' Kean is a wry raconteur, an intimate sharing his life story and interspersing it with displays of admirable range to conjure the various company managers and committee members he comes across. His manner is indeed so engaging that it overcomes the limitations of the production. For instance, the changes of scene that calibrate each act are largely unnecessary, because Kean is rather so free and easy with his narration, his showman's sleight of hand shuffling past and present, that the Turner-lite backdrops become redundant when a tavern or dressing room might be more appropriate to the retrospective relation of the life story.



Hughes thus ably conveys the greatness that was evident to men such as Byron and Hazlitt (not many actors would commend their reviewers as "astute young men" as Kean does the latter). But because there is little distance between audience and performer – no, performers – it is difficult to see the tragedian's own fatal flaws. With more flecks of arrogance, delusion or inconsistency, we would have been better able to glimpse him in his less pleasant but truer complexity. Yet with Hughes on his side, Kean will always seem more heroic than tragic.

Perhaps the true tragedy of Kean is not of a man undone by ambition, drink or lust, but of one who cannot separate his life from the performance of it. While he can, at his height, imagine claiming Kemble's crown as the King of London's Theatreland, at the end he cannot even reach the prop crown of Henry V off a chair as he lies prostrate with gout on the dressing room floor. So if it is the case that a man who lived for tragedy has made a tragedy of his life, then he is lucky to have an actor as understanding as Hughes is to perform it for him.

## Kooky Capers in a Bare Forest As You Like It

Shared Experience at Richmond Theatre until 11th November, then on tour until 9th December

When Richmond Theatre opened on 18th September 1899 as Frank Matcham's latest architectural tour de force, it's first offering was As You Like It, but would that staid audience have recognised the latest offering of William Shakespeare's muchloved comedy that opened its national touring version this week?



They may have been a little bemused by Shared Experience's colourful kooky setting, and perhaps by the exuberant inclusion of contemporary dance and

music, but they would have been at home with the familiar words, as the production has been true to Shakespeare's script. All of the play's well-known songs are there, but with sparkling new adaptations by composer Richard Hammarton, whose powerful sound designs set the mood. With the inclusion of movement director Siân Williams' dances, the

production edges towards "As You Like It, the Musical".

Now, what about this setting? It is meant to be 2017, and has modern paraphernalia such as mobile

phones. However, it often feels more 1967 with its flower-power hippies and Gilbert Scott red phone box. Shakespeare clearly wanted to contrast the two worlds of As You Like It, the stern court in the city and the idyllic Forest of Arden in the countryside. Designer Libby Watson has certainly achieved the contrast. The court becomes a politicians' committee room (Portcullis House rather the Palace of Westminster), black and white; Nespresso machine, water cooler: stark. The countryside is full of colour, open, bare; Phone box, bench: exposed.





When the back wall of the room unzips to reveal the country, it impacts with a momentary wow ... but then there follows wait-a-minute thoughts. The pastoral pastel of the foreground clashes with the lighting designer Chris Davey's cyclorama of saturated light-washes. There are beautifully stylised poetical images projected across the cyc, but also across the stage items, leaving their shadows on the scene and with their edges visible. Isn't this meant to be a sanctuary beyond the reach of the Duke's henchmen? It looks like the edge of Richmond Park, but scruffy,

a recreation ground accessible by supermarket trolleys. Why has Arden got the Duke's water-cooler? Why is the telephone box crammed with bookshelves? And why does a forest have only one Waiting for Godot bare tree, that doesn't so much sway in the wind as wobble at the roots? ......

### Twickenham Riverside Park

Twickenham is currently waiting with bated breath to find out the results of the Council's latest consultation on the Twickenham Riverside plan – the Francis Terry flats.

At the previous consultation the biggest issue was parking on the riverside, followed by a wish to bring back an outdoor pool to Twickenham Riverside.

The Twickenham Lido plan, with boathouses, can be incorporated into most of the proposals for Twickenham Riverside; it is thought by its supporters to be a way to make Twickenham a destination and a focus for sport and leisure.

Like the plans for the lido, the Riverside Park scheme is ignored by the Council.

Twickenham Lido and the Riverside Park have, between them, supporters on Change.org petitions of over 5,000. During the last week, the Riverside Park has incorporated Twickenham Lido within its plans.

The Twickenham Lido plan is for a lido at the bottom of Water Lane, whereas there is flexibility for it's positioning.

## Six St Mary's Athletes Selected for Team England at the Commonwealth Games



The English Team competing in the 2018 Commonwealth Games have selected six athletes and alumni of St Mary's University, Twickenham.

Hosted in Gold Coast, Australia, in April 2018, the Games bring together the leading athletics talent from across the Commonwealth to compete for their countries.

Five Endurance Performance and Coaching Centre (EPACC) athletes will be competing at the games. Rio 2016 Olympian Elliot Giles with be competing in the Men's 800m alongside London 2012 800m finalist Andrew Osagie. They will be joined in the Women's 800m by Adelle Tracey who reached the London 2017 World Championships semi-final.



Elsewhere, Rio 2016 Olympians Charlie Grice and Andy Vernon will be competing. Charlie will run in the Men's 1500m, having reached the finals at Rio, whilst Andy will run in the Men's 10000m.

St Mary's Alumna and Olympian Jade Lally will also be competing in the Women's Discus. Jade, who still regularly trains at St Mary's, competed at Rio 2016 and more recently in the London 2017 World Championships.

Speaking of their selections, Director of Sport Andrew Reid-Smith said, "St Mary's has gone from strength to strength in recent years with selections at major competitions. We saw 25 athletes compete at the Rio 2016 Olympic Games and 11 at London 2017 World Championships. 

"A card was put through my door about the second week in October saying that they had been unable to deliver a parcel, would I please ring them to arrange a time for delivery. As I was not expecting a parcel I was puzzled, also my husband was home and said no one had knocked on the door. I decided it was a mistake and that they had the wrong house number and thankfully I had a gut feeling something wasn't right. If I had rung that number and started to hear a recorded message I would have already been billed £315 for the phone call."

Please see below image: Email spam doing the rounds purporting to be a Notice of Intended Prosecutions (NIP) from Greater Manchester Police where by the recipient has been named by the registered keeper as the driver at the time of the speeding offence. DO NOT CLICK ON ANY LINKS within the email and preferably DO NOT OPEN the email - these things contain malware, spyware and ransomware and are used to hack into your computer and attach viruses to it.

A real NIP will be sent by police in the post and not by email. The clue that it is spam is in the sender's email address (see below) - clearly NOT a police email!

## National Physical Laboratory and Imperial College London launch new virtual lab to establish the UK Centre for Engineering Biology, Metrology and Standards

NPL, the UK's National Measurement Institute (NMI), and SynbiCITE at Imperial College London, has announced the establishment of a new £7 million virtual lab to underpin their joint Centre for Engineering Biology, Metrology and Standards to help the UK synthetic biology industry improve the manufacturing and adoption of new products – in partnership with LGC and NIBSC.

The virtual lab is a new collaboration between institutes undertaking world-leading research in biological measurements, which positions UK as a global leader in the industrialisation of synthetic biology: NPL, LGC, the UK's National Measurement Laboratory for chemical and bio-measurement, NIBSC, and Imperial College London's SynbiCITE, the UK's National Industrial Translation Centre dedicated to the commercialisation of synthetic biology. This new lab will develop and provide relevant reference materials and methods in the form of a toolbox aiming to improve the reproducibility of research results that will help convert innovation in

synthetic biology into valuable products

and services.

The lab is part of £17 million of new government funding announced by The Chancellor of the Exchequer two weeks ago to help translate the UK's scientific expertise into real life treatments, and will focus on accelerating the application of synthetic biology in life sciences.



As a burgeoning sector, synthetic biology cuts across different concepts, capabilities and technologies which need validating before they are ready for commercialisation. There are also many variables to factor in when looking to scale-up the production of a synthetic biology product. All of these need to be referenced to standards to provide certainty in the consistency of the product performance, and confidence in the ability to measure and evaluate key performance parameters. These are the main attributes in deciding which products are adopted, and ultimately commercialised, by industry. Establishing industry-led measurements and standards will safe-guard the quality and safety of products, and allow companies to maintain competitiveness and enhance innovation. This innovation

hub will further engage with industry to help transform high-value manufacturing into high-value products that will deliver economic and societal benefits.

This timely and critical investment will support the development of exactly these capabilities. Industry confidence in the higher order biological reference materials that are developed will be ensured through their validation and certification by the UK's National Measurement System (through NPL, LGC and NIBSC). Applications that will benefit most include advanced therapies such as gene, cell and regenerative therapies, as well as the discovery and manufacture of new antibiotics.

Each collaborating institute will offer its individual expertise to assist the UK in becoming the world leader in the industrialisation of engineering biology. As the UK's NMI, NPL provides the framework, facilities and expertise to enable measurements at the molecular, cellular and sub-cellular levels to be reproduced with confidence. LGC and NIBSC will provide specialist expertise in biological standardisation, in the form of genomic and bioactivity measurements, respectively.

Dr Michael Adeogun, Head of Life Sciences and Health at NPL, said: "A key point in the government's Life Sciences Industrial Strategy, launched in August, is the need for the development and quick adoption of innovative drugs and therapies. Synthetic biology offers great opportunities here but requires underpinning measurement to ensure that new products are realised and can be commercialised more quickly. Much as good measurement is vital to ensuring fair exchange of physical goods, it is also integral to establishing the same trusted exchange of knowledge, and therefore is an important factor in accelerating access to new innovations. NPL is delighted to announce the first phase of establishing the UK Centre for Engineering Biology, Metrology and Standards, to achieve this."

Professor Paul Freemont and Professor Richard Kitney, Co-Directors of SynbiCITE at Imperial College, said: "The new centre is part of a wider collaboration with the NPL, LGC and NIBSC in Engineering Biology, Metrology and Standards. Synthetic Biology/Engineering Biology has, since 2013, been recognised by the Government as a key area for economic growth – for example as an important driver of the bioeconomy. We view the development of new metrology and standards for the field as being essential for effective industrial translation – through accurate reproducibility, coupled to high levels of reliability. The partnership with NPL (including LGC and NIBSC) is seen as being an essential step in this process."

## Magical Venice

I often get travel ideas whilst I am helping my clients realise their dreams! That was the inspiration behind my recent trip to Venice with my parents. I had been working on a journey to Venice for a lovely client of mine, and we were looking at the palaces they have there and it looked so fantastic so after I had worked on her itinerary and found how reasonable it was to travel there and how lovely the accommodation looked, I thought a little trip there might be a great idea. I found out that my parents having travelled to most of the world as seasoned travel agents, also hadn't been so then I decided that it would be a real adventure. I booked it about 4 months before the date of travel which isn't great if you are looking for a good deal, but nevertheless I found a really great 3 star in a fantastic location for just about £300 for each of us with the flights included.











We just went for the weekend, and although I am sure that you could do a lot more if you stayed for longer, we had a really great time just staying for 2 nights and 3 days, we visited the Doges Palace and St Marks Basilica on the first day and it was fantastic because our hotel was just 10 minutes from St Mark's Square and that's were all the excursions leave from. We booked the tour before we went as we knew we were going for such a short time and didn't want to waste time there looking for things to do, and it was very good because we had skip the line tickets and we saw the poor souls queuing for hours to get tickets! In the afternoon that day, we walked pretty much the length of Venice from St Marks to Cannaregio where the old and new Jewish Ghettos are. It is probably the poorest part of Venice Island and the journey passed some really neglected parts, but it was worth it because as we crossed the bridge into the Ghetto Nuovo we were greeted by a lovely sight of a big square, very clean with trees and a few families sitting on the benches waiting for Shabbat to finish. Their children were running around laughing, playing and speaking Hebrew. There were a few restaurants, some shops & quite a few galleries, a hotel and a Kosher bakery. We brought some coffee and some cakes and sat in the square. There is a memorial to the holocaust. When the Nazis came to round up the Jews, the Jewish elder they tasked with giving them the list of names of the inhabitants killed himself rather than betray his fellow men, women and children. They did take about 250, only about 7 survived and managed to return.

The second day we had brought in advance tickets to see the 3 islands of Murano (where they make the famous Venetian glass) Burano, where they traditionally made lace and Torcello which used to be a thriving community but is now barely inhabited. It was a really great excursion and took about 4.5 hours with about 45 minutes on each island. Murano was fascinating to see them blowing the glass. They really are masters in their trade and the demonstration was really lovely. We went to the show room afterwards and the items looked really beautiful. The prices are really quite high and we didn't buy anything. Burano is really very pretty with lots of brightly coloured houses. The main industry here used to be lace. They still have a few shops selling the traditional lace but it is a dying trade and they say the natives don't make it anymore. I think they still work in fishing though, and that's the reason the houses are painted brightly so the tired fisher men can see their houses easily in what is often foggy weather. Torcello was a little boring. It has a few nice restaurants and it is very pretty too, but most of the inhabitants have left and you can only see the remains of its older glory in the decaying remains of a bell tower and cathedral. There is a museum there too but we didn't have time to look.









I can thoroughly recommend a trip to Venice to anyone! It is really affordable to go from the UK.

A weekend like ours can cost just £250 per person, for the flights and accommodation. You take a ferry from the airport across the lagoon into Venice Island which is also very reasonable for the return journey. Venice is completely magical, a beautiful ancient world preserved as it must have been many hundreds of years ago. It really takes your breath away. We took the public ferries to get around along the Grand Canal and the views are unbelievable.

## Play the Game Rules for Living



by Sam Holcroft at The Rose Theatre Kingston, until 18th November RTK, English Touring Theatre and Royal and Derngate Northampton co-production Review by Melissa Syversen

On the surface Rules for Living, currently playing at the Rose Theatre Kingston, seems like your average farce. It follows a standard farce story line we have all seen time and time again: It is Christmas day and we are introduced to your seemingly normal middle-class British family as they gather for their annual Christmas lunch. The younger brother Matthew has brought his actress girlfriend Carrie to join the festivities for the first time. The matriarch of the house Edith puts everyone to work to create the perfect lunch for Francis the father, who is returning from the hospital to join the family. We then follow this family as a seemingly pleasant Christmas tradition descends into chaotic revelations of secrets, hostilities and bitter grudges.





Rules for Living, however, despite its initial impression, is not your average farce. Playwright Sam Holcroft has created a format wherein the characters exist that sets this play apart. By adopting a literal take on her title, she gives five of the seven characters specific rules they must live by. About ten minutes into the play, a big red sign is projected onto the set for everyone, including the character it applies to, can see. The first rule we see is this: Matthew must sit down when telling a lie. What

follows thanks to this premise can only be described as top notch physical and non-verbal comedy, adding a nice layer to the already well written and witty script. As the play goes on each character is given

their rules and, as the Christmas lunch continues, each rule is further expanded, growing increasingly demanding and ridiculous.



The revelation and the timing of the rules are often as funny as the

enactments themselves. And bless this cast, they really go for it. There are genuinely impressive



contortions such as a desperate Matthew trying to get his bum on a seat so he can lie and get himself out of the figurative hot seat. As wonderful as all the rule-bound family members are, I must especially mention Paul Shelley's Francis. Francis might be bound to a wheelchair instead of abstract rules but he is no less funny. The timing of his single words, grunts and facial expression are just as funny and well-timed as Carlyss Peers' Carrie's desperately compulsive dancing across the stage. ........

## RuTC Hosts Goalball for the All Blacks

On Friday 3 November, Richmond upon Thames College (RuTC) hosted a goalball session for players from the New Zealand All Blacks rugby team. Sponsored by AIG, the official insurance partner of New Zealand Rugby, the session was organised to bring together AIG's charity partnerships with the Royal National Institute of Blind People (RNIB) and Endeavour Fund to create a unique experience with the All Blacks while celebrating the power of sport.

Goalball is a team sport for athletes with visual impairments, originally devised in 1946 as a means of assisting the rehabilitation of visually impaired World War II veterans. It is played by two teams of three using a ball with bells inside. The object of the game is to throw the ball into the opposing team's net while defenders attempt to block it with their bodies.

After being introduced to the sport and learning the basics while blindfolded, the five All Blacks players: Damian McKenzie, Waisake Naholo, Ardie Savea, Lima Sopoaga and Codie Taylor teamed up with AIG, Endeavour Fund and RNIB players and went head to head in a series of matches.



RuTC Supported Learning students Georgia Herdman, Paige Ikin, Melisa Showsmith and Yan Rudnicki had the opportunity to meet players from the New Zealand All Blacks. The event took place the day before the All Black defeated the Barbarians at Twickenham Stadium.

Mark Brough, Sports Development and Facilities Manager at RuTC commented, "It was a pleasure to once again host an AIG sport event at the college. The students and members of the sports team attending enjoyed finding out more about the sport and afterwards expressed an interest in introducing the sport at the college. Students and staff were grateful for the opportunity to attend and have the opportunity to meet some of the players."




#### 28th November – Letters from Baghdad (UK)





### 12th December – The Other Side of Hope (Finland)

In addition to the terrible human deaths and casualties that have been inflicted by indiscriminate use of air weapons, many pets have also been the unfortunate victims of air weapons.

Cats Protection's air gun licensing petition has already received over 76,000 signatures and we would like to thank all of those who have signed the petition.

Cats receive life-changing injuries from air guns such as limb amputation or loss of an eye. A 2016 Cats Protection survey of vets found that 46% of reported incidents result in fatalities. We welcome the government's intention to review the regulation of air weapons licensing. We are asking the government to licence air guns in England and Wales, bringing us in line with Northern Ireland and Scotland.

Our monitoring shows nearly four cats a week are reported as killed or injured by an air gun in the UK – the actual figure is higher as many remain unreported.




